Re.: UPDATION OF PAN, KYC, NOMINATION AND BANK DETAILS

Please take note that the Securities & Exchange Board of India (SEBI) vide its circular SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/655 dated November 03, 2021 read with clarification circular SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/687 dated December 14, 2021 has notified simplified norms for processing investors request by RTA and mandatory furnishing /updation of PAN, KYC, Bank details, Nomination details and specimen signature by all the shareholders holding shares in physical form.

In the said circular, SEBI has stipulated that if the shareholders holding shares in physical mode do not update the PAN, KYC and Nomination details or these details are not made available to the Company and their Registrar and Share Transfer Agents (RTA) by 31st March, 2023, then such folios shall be frozen by RTA on or after 1st April, 2023 as per the directive issued by SEBI and the RTA shall also not process any service requests or complaints received from the holder(s)/claimant(s), till PAN, KYC and Nomination documents/details are received effective from January 1, 2022.

Therefore, order to avoid freezing of folios you are requested to comply with the following procedure at the earliest:

- 1. First Link your PAN with Aadhaar and update the valid PAN with RTA in ISR-1 latest by 31st March 2022;
- 2. Update your KYC details in Form ISR-1 and Nomination details in Form SH-13 with RTA latest by 31st March 2023;
- 3. If you want to register/update your signature in Company/RTA records, submit ISR-2 duly verified by Banker;
- 4. In case you do not wish to nominate any person(s) with whom shall vest, all rights in respect of such shares in the event of his/her death, you are requested to file "Declaration to Opt-out" in Form ISR-3 with our RTA;
- 5. If you want to change/cancel the existing nomination, then Submit:
 - a) Form SH-14 to make changes in the nomination details;
 - b) Form SH-14 and Declaration to Opt-out (ISR-3) for cancellation of existing nomination;
- 6. Submit Bank Account Details (Name of Bank with Branch address, Account Number, IFS Code) to our RTA.

You are requested to update your Email Id and Mobile No. with company's RTA for receiving communications by electronic means. The copies of Form ISR-1, ISR-2, ISR-3, SH-13 and SH-14 as mentioned above are enclosed and the same are also available on the company's website www.modisteel.com as well as RTA www.skylinerta.com.

Please get your shareholding converted to Dematerialized Form to eliminate the risk associated with the physical share certificate including Freezing of Folio.
